Dr. Gary Maslow, MD, MPH, is an Assistant Professor, Medical Director of the Duke Integrated Pediatric Mental Health Clinical Practice Unit and co-chief of Duke's Division of Child and Family Mental Health and Developmental Neuroscience. He is also the director of the NC Psychiatry Access Line (NC PAL). Patient reviews rate him as "excellent" across all categories including his caring attitude, ability to answer patient questions, thoroughness of appointments, and amount of time he spends with patients. Dr. Maslow is a dedicated and accomplished physician, educator, researcher, and policy advocate.

In 2017 the I/DD Medical Health Home Initiative, funded by the NCCDD, awarded Dr. Maslow a small grant to develop telephone consultation services that offered a multidisciplinary resource to improve knowledge, skills, and ability of primary care practices and providers to care for patients with I/DD. Dr. Maslow's leadership has resulted in the growth of NC PAL into a statewide program with expanded partners and funding and an established NC PAL-IDD team. His vision of creating medical homes that are proactive in caring for the physical and mental health needs of children with I/DD and their families aligns with the core principles of person and family-centered care and integrated care. Dr. Maslow believes that physicians must pay attention to people's lives outside of the narrow window of their medical and disability diagnosis and work to ensure that each individual with I/DD is connected to the systems they need and that these systems work in concert for the benefit of the individual and family.

Dr. Maslow is known as someone whose words and actions inspire others to join him in achieving behavioral health equity for North Carolina's children, youth and families. Dr. Maslow has made a lasting contribution towards advancing innovation and quality care in services for people with I/DD and is a most deserving candidate for the Holly Riddle Distinguished Leadership award by advance innovation and care in services for people with I/DD.
