Dr. Harum advocates for people with I/DD in a direct way by advocating for the best care for her patients --- whether that be to the parents/guardians, other providers through care collaboration, or by reaching out to state run facilities that are overcrowded, overburdened, and ultimately failing the kids who need them. Sometimes the best path forward for a patient is a scary one that parents (+ even the patient themselves) are afraid of, or don't understand, and she will sacrifice as much time and resources as needed to help ensure patients are choosing the best care that will improve their quality of life. Advocating for patients, who most times can't even speak for themselves, is what she does all day long in her exam room. She works 7 days a week and is on call 24/7 for per patients. They are never alone because she is always looking out for them.

Dr. Harum is double board certified in general pediatrics and Neurodevelopmental Disabilities and has worked in this field for 30+ years. She is a MAPS fellow and has her own private practice (Clinic for Special Children) dedicated to integrative pediatrics and specialty care in Wilmington. She works tirelessly to ensure her patient families are fully informed, does independent research, and has developed her own protocols for treatments. Her strength is her passion and how much dedication she has to this community. When medicaid cuts continue to happen that put her clinic in financial risk, she works 10x harder to ensure she can continue to care for these children/adults with disabilities. There is always a new program or service being developed (or adapted from existing therapies) with their benefit in mind. At her clinic she has everything from diagnostic programs for ASD + ADHD, comprehensive consultations for a wide range of disabilities (CP, Down Syndrome, ASD, ADHD, Sickle Cell, Rhetts, Fragile X, etc), infusion protocols, HBOT, Direct care membership plans, medicinal kits and her own apothecary line (Clinic Naturals), and other therapeutics (including detox footbaths, alpha stim, Play Attention, Behavior Intervention Sessions, etc).

Dr. Harum has developed a non-profit (Therapize) to opperate alongside her clinic which provides free/low cost programs to people with disabilities. The nonprofit does have its own events like Haircuts and Hayrides and Quiet Santa, but also funds other organizations when they are already meeting community needs. She has partnered with Power Up Therapy and Coastal Buds most recently.

Dr. Harum's work has a direct impact on people with I/DD and their health and behavioral gains and outcomes. She has improved quality of life for so many individuals in our community and has patients travel to her from all around the country/word. This fact alone is enough reason to view her as a leader for advocacy and shows she influences positive change in the lives of people with intellectual and developmental disabilities. Her work impacts families significantly by providing diagnostics, treatment, and hope to families who have loved ones with moderate to severe health conditions and behaviors. This requires a high level of care coordination and medication management.

It is obvious from her credentials and experience that she is an expert in her field, but that is not what makes her special. No matter how many long grueling hours Dr. Harum has worked, she always makes time to prioritize the stability of her patients and anyone lucky enough to work with her sees her dedication to helping children. She has devoted her entire professional career to helping families find as much relief from their (often devastating) situations and has sacrificed so much in her personal life to do so. Dr. Harum goes above and beyond by always being available and willing to fiercely advocate for her patients when they are not receiving the services they need from state funded programs and therapies. Patients often describe her as "their Savior." Dr. Harum is a genuine, kind hearted, and giving person, but the most inspiring thing about her is her ability to have faith in healing even the most broken of children and to fight for her patients even as they experience setbacks. She never takes no for an answer. She endlessly seeks out the answers to her patients ailments, she is always researching and developing new protocols and programs for innovative treatment of their conditions, and she often does this at her own financial expense when her patients are not able to on their own. In the recent months this has become more frequent as changes in the Medicaid Insurance programs have left her feeling as though physicians needs are being forgotten about. When she is not treating patients at the Clinic, she spends her "free time" working for her Non-Profit Organization, Therapize, designed in her own words to "help bring free therapeutic programs to the families affected by special needs children in our community, in a fun way." Her unwavering dedication to finding solutions for the special needs population is why she is immensely deserving of recognition and celebration.
