They have worked within the Disabled community for over 23 years, including:

- 14 years teaching Autistic, Neurodivergent, and Disabled students in local public, charter, and private schools.
- 4 years working the Durham Department of Parks and Recreation in inclusive summer programs
- 10 years coaching a variety of sports through Special Olympics
- 5 years on the Board of Special Olympics

They founded CANDOR, as the Autism Support and Advocacy Center, in 2010 as a pathway for challenging systemic barriers and advocating for more inclusive and intersectional approaches to social change. Through CANDOR, they have developed and implements projects that work at the intersection of disability, gender, environmental, economic, food, and racial justice.

In 2020, they opened Part & Parcel, under CANDOR, and it has become a thriving business that is exclusively run and operated by Neurodivergent, Chronically-ill, and Disabled people.

They have been a speaker at Regional and National conferences and received the Mayor's Award from the Committee for Person's with Disabilities.
